CHHR Exam Scholarship Application Information



You are a healthcare human resources professional – it's time to recognize your expertise and get certified through the AHA Certification Center to gain the recognition you deserve! ASHHRA members who apply for a CHHR Scholarship between January 1, 2016, and December 31, 2016, will receive a voucher for the full CHHR exam fee (a \$295 value). This is a limited-time, exclusive offer only available to active ASHHRA members who meet the eligibility requirements.

Note: This offer does not apply to any existing exam applications or to members who are currently certified. Exam applications already submitted to AMP are not eligible for this scholarship.

QUALIFICATIONS:

- Applicants must be active ASHHRA members in good standing with the Association
- Applicants may not have received any other ASHHRA scholarships or grants within the last year
- Applicants must meet the exam eligibility requirements listed below.

INSTRUCTIONS:

1. Complete this Scholarship Application online at <https://www.research.net/r/chrscholarship>
2. Do not apply for the exam, schedule an exam, or contact AMP (the exam administrator) during this time.
3. Successful scholarship applicants will receive a voucher for the exam fee. Recipients must submit this voucher with the CHHR exam application to AMP before the voucher expires. Vouchers will be mailed the same day as the applicant is notified of their award status.

ELIGIBILITY REQUIREMENTS:

A candidate must fulfill one (1) of the following educational and occupational experience requirements.

- Master's degree or higher from an accredited college or university plus five (5) years of human resources experience in a healthcare setting* or with a provider of human resources services to the healthcare industry.
- Bachelor's degree from an accredited college or university plus six (6) years of human resources experience in a healthcare setting* or with a provider of human resources services to the healthcare industry.
- Associate degree or equivalent from an accredited college or university plus eight (8) years of human resources experience in a healthcare setting* or with a provider of human resources services to the healthcare industry.

**Includes experience with a provider of human resources services to healthcare facilities such as research, VA or other hospitals; medical practice groups, ACOs; IDNs; MCOs; acute care, rehabilitation or skilled nursing facility; hospice or home health agency.*

Requirements

- Scholarship vouchers are valid for six months after issuance date.
- Scholarship recipients are responsible for sending their application directly to the exam administrator (Applied Measurement Professionals) with the payment voucher before the voucher expires.
- Scholarship vouchers are non-transferrable and for first time use only.
