ASHHRA Announces Tenth Thought Leader Forum

CHICAGO – June 2014 – The American Society for Healthcare Human Resources Administration (ASHHRA), a Personal Membership Group (PMG) of the American Hospital Association (AHA), in collaboration with TIAA-CREF, a financial services company and long-standing partner of ASHHRA, plans to convene its tenth Thought Leader Forum (TLF).
